The first counseling for admission into B.A.LL.B. (a five-year integrated course offered by Andaman Law College, a constituent college of Netaji Subhash Chandra Bose Institute of Higher Learning) will be held on 17th July, 2026 (Friday). Counseling will start by 10 A.M. sharp, and the applicants are requested to report by 9.30 A.M. at the college auditorium.

The final merit list of eligible candidates for the Academic Session 2026-27 has already been published in the Common Online Admission Portal for Colleges (CCAP) (<https://collegeadmission.andamannicobar.gov.in>) and also displayed on the college notice board.
