The third counselling for the vacant seats for admission into B.A.LL.B. (Five-year integrated course) offered by Andaman Law College, a constituent college of Netaji Subhash Chandra Bose Institute of Higher Learning (NSCBIHL) will be held on 03rd August, 2026 (Monday).
