If the seats are un-utilized from the respective categories, the same may be allotted from Category-V as per merit.

It is further brought to the notice of all concerned candidates that the aforesaid surrender seats of B.A.L.L.B, B.Sc (Agriculture), General Nursing & Midwifery, B.Tech (Biotechnology), B.Tech (Fisheries Engg) will be allotted from the respective categories from where the seats have been surrendered.
