

#### ABOUT THE COLLEGE

Welcome to Andaman Law College (ALC). It has been established with a vision to offer legal education to the people of A & N Islands. The College is located on the picturesque Islands of Andaman & Nicobar and has emerged as a prominent centre of legal studies.

It came into existence in 2016 under the aegis of Andaman and Nicobar Islands Legal Education Society (ANILES), a registered society under the Societies Registration Act, 1860. The institution is fully funded by the Andaman & Nicobar Islands Administration & governed by its own rules and regulations. The ANILES is presided over by the Hon'ble Lieutenant Governor of Andaman & Nicobar Islands, who serves as the President of the Society. The Executive Council is chaired by the Chief Secretary, with the Commissioner-cum-Secretary (Education) of the Andaman & Nicobar Islands Administration acting as the Vice-Chairman.

The college is affiliated to the Pondicherry University and recognized by the Bar Council of India. The College offers a full-time B.A.LL.B. (Five Year Integrated Course) Programme.

- e) Category Certificate— Scheduled Tribe (ST)/Disability Certificate/Other Category (if applicable, strictly as provided in the Annexure of this brochure.)
- f) Bank Account Details (front page of the bank passbook)
- g) Aadhaar Card Number

#### PROGRAMME OFFERED

The Andaman Law College is affiliated to Pondicherry University and approved by Bar Council of India, and is currently offering B.A.LL.B. (Five Years – Integrated Course). This course has been designed by the Pondicherry University as prescribed by the Bar Council of India.

## **Eligibility Criteria**

# (As mandated by the Bar Council of India in its Rules of Legal Education - 2008)

The BCI, being the regulating authority for legal education in India, has prescribed the following eligibility criteria for candidates to get admission in the B.A.LL.B. (Five Years – Integrated Course) Programme:

- a. Passed the Higher Secondary School Examination (10+2) conducted by CISCE/CBSE/ any State Government Board or equivalent recognized by Pondicherry University securing not less than 45% marks in the aggregate in the case of general category and 40% marks in aggregate in the case of SC and ST candidates.
  - However such a minimum qualifying marks shall not automatically entitle a person to get admission into the institution but only shall entitle the person concerned to fulfill other institutional criteria notified by the institution or by the government from time to time to apply for admission.
- b. Not completed 20 years of age in as on 1<sup>st</sup> July of the year of admission. In case candidates belonging to SC/ST, they shall not have completed 22 years of age as on 1st July of the year of admission.

Consequent on passing of interim order by the Hon'ble Supreme Court staying the age limit for law admission prescribed by BCI, others may also apply. However their admission will be subject to the outcome of the final order to be passed by the Hon'ble Supreme Court.

Candidates who have obtained (10+2) through Open University systems directly without any basic schooling or qualification are not eligible for the admission.

#### SANCTIONED INTAKE AND RULES OF RESERVATION

The intake of students for admission is limited to 45 as approved by Pondicherry University. Seat reservation/allocation of seats will be strictly as per the Rules and Regulations of the Government of India and Andaman & Nicobar Islands Administration. In the event of changes, if any, in the allocation of seats for various categories, the same will be intimated before counseling of students

through the website of Andaman & Nicobar Islands Administration, college website and in the local daily. However, at present the seats are allocated in the following manner:

#### 10% Reservation for Economically Weaker Sections

Candidates belonging to the Economically Weaker Sections (EWS) intending to seek reservation under the EWS Category should submit the certificate issued by the Revenue Department.

#### Reservation for Divyangjan (Person with Disability)

5% seats are reserved for PWD candidates. To qualify for selection under PWD, such a candidate should have 40% disability and above, duly certified by the Competent Medical Authorities under the provisions of Persons with Disability Act.

Various categories, as specified earlier, can be claimed by attaching the certificate as per the Annexure detailed below. The candidate, who obtained such certificates previously, may submit the same and they need not obtain the certificate afresh.

# Category - I Tribal

Certificate as per **Annexure I** duly signed by Tehsildar of the jurisdiction to be attached to support the claim of the candidate.

# Category - II Wards of Central Govt. Employees & those on deputation with transfer liability.

Central Government Employees & those on deputation with transfer liability to serve outside the Union Territory provided their wards have studied the last two years in the Islands and passed the qualifying examination from a school in the Islands. Certificate as per **Annexure-II** duly signed by the competent authority of the concerned department to be attached to support the claim of the candidate.

Category - III

Pre-1942 settlers & those who were settled under various rehabilitation schemes introduced after reoccupation of Island.

Certificate as per **Annexure-III** duly signed by the Tehsildar of the jurisdiction, to be attached to support the claim of the candidate.

Category - IV

Wards of Locals & Central Govt. Employees (who do not fall under category – I, II or III) having no transfer liability to serve outside the Union Territory, provided their wards have had 10 years education in the Islands.

Certificate as per **Annexure-III** duly signed by the competent authority of the department concerned, to be attached to support the claim of the candidate.

Category - V

General Merit Quota

Open to all residents of Andaman and Nicobar Islands, subject to the condition that their wards should have studied the last 02 years in the Islands and passed the qualifying examination from a school in the Islands. Class XII certificate to be attached to support the claim of the candidate.

#### **Differently Abled Persons**

The candidates will be required to submit a valid disability certificate from the competent authority issued not more than 03 months prior to the counseling/admission date. The certificate as given in **Annexure-IV** must indicate the nature and extent of physical disability. No certificate other than this shall be accepted for claiming the seats reserved for Divyang. Provided that the seats reserved for the Divyang remain unfilled due to the non-availability of eligible candidate(s) under this category, the same shall be treated as unreserved. The provisionally selected candidate in the Divyang Category will be

examined by a Special Medical Board constituted for this purpose by the Administration, and the decision of the board shall be final.

#### **Other Backward Class Candidates**

OBC candidates claiming relaxed eligibility criteria as indicated earlier must submit a certificate as per **Annexure-V** duly signed by the Tehsildar of the jurisdiction.

#### **Duration of Semester**

Each Semester shall means and includes a minimum of 15 weeks duration. (Approx. 90 working days)

#### **ATTENDANCE**

- a. The student is expected to put up 100% attendance. However, a concession of 25% will be allowed to all the students.
- b. A candidate in order to qualify himself/herself to appear the semester examination shall have to secure at least 75% of classroom attendance in each paper of that semester.
- c. A candidate who represents the Institution in any International/ National/State Level Academic or Sports Competition with prior permission of the Principal shall be considered up to 15% attendance in each Semester.
- d. A candidate, who has secured 60% to 74% attendance due to illness, may submit medical certificate from a registered medical practitioner for adjustment of deficit attendance. On all genuine reasons the Principal can allow the student to attend examinations.

#### **FACILITIES**

#### **Smart Classroom**



The classrooms are equipped with advanced educational technologies to enhance the teaching and learning experience. This ensures quality teaching and learning ambience.

#### Library

Library is the heart of any academic institution. ALC has a rich collection of over 3714 books covering wide range legal and allied subjects, comprising of textbooks, reference books, journals, reports etc. The Library subscribes good



number of law journals and other periodicals. Computer based digital library is part of our library, where in we have subscribed to many online law journals and resources including SCC Online etc. This is part of our e-library initiatives.

The library services are functional from 09:00 am to 05:00 pm on all working days. The library has an open access system to facilitate students to have access to library resource. The library aims to establish a network with various other law libraries in India in the days to come.

Every year Library adds a good number of books. In 2025, books worth over two lakh rupees were added. Many books in this collection are relevant for various competitive examinations. Other books include self-help books and literary classics.

The students of Andaman Law College are provided with the facility of a reading room where one can read newspapers, magazines, books, etc. Library has reprographic facility tool.

#### **Computer Lab**

The campus is *Wi-Fi* enabled. The lab has 15 high end computer systems. The lab is supported with a high-speed bandwidth and printing facility. This will enable the students to keep themselves abreast with the day to day developments in law.

Moot court is a place where students learn court craft. Moot court enables students to gain practical experience. It allows the student to practice presenting cases in a real life setting, take part in trials, act as a representative for the parties and learn how



to conduct themselves in the court of law. Moot court is equipped with all the modern facilities required.

## Legal Aid Clinic in association with State Legal Services Authority



Legal Aid Clinic in association with State Services Legal Authority is recently inaugurated by Hon'ble Justice Surya Kant, Judge, Supreme Court and Executive Chairman, National Legal Services Authority and Hon'ble Justice Dipankar Dutta Judge, Supreme Court and Patron

ANSLSA. It aims to provide free legal advice to the needy as per Article 39A of Indian Constitution. Further, the college is disseminating legal literacy by conducting legal camps and awareness programmes in the island. This is part of our academic curriculum as prescribed by the BCI in the name of Clinical Legal Education. This will give exposure to the students with real time legal issues.

#### **Students Internship Programme**

The Bar Council of India (BCI) mandates internships for law students. The students are required to undergo a minimum of 2 weeks of internship per semester or four weeks per academic year. This will be taken up as per Internship policy of the college.

#### **Physical Education and Sports**

A sound mind dwells in a sound body. At present, the college has indoor facility for table tennis, carom, chess and badminton. In collaboration with the JNRM College, students are allowed to utilize the outdoor sports facility for football, basketball, volleyball, cricket etc.

#### **IGNOU Learner's Support Centre**

The Andaman Law College will soon have IGNOU Learner's Support Centre. It will offer different Certificate/Diploma Programmes relating to Law. Andaman Law College students can have an advantage of taking these programmes as Add-on certifications. Now, regular college students are allowed to join distance education programs as per NEP 2022.

#### Hostel

At present, the Andaman Law College has no hostel facilities. However, the eligible students from inter-islands are accommodated at DIET Hostel, Garacharma, subject to availability of rooms. Eligible inter-island students will get a stipend of Rs.1500/- per month.

#### CONDUCT AND DISCIPLINE

Students are expected to maintain high degree of discipline, conduct and behavior. They are Lawyers in making. Hence, they should imbibe all good qualities as students.

The students are supposed to follow the dress code.

#### **Dress Code**

As per BCI mandate, the students should follow the uniform on all working days in the campus.

Boys: White Shirt, Black Trouser, Black Tie, Black Shoes and White Socks

Girls: White Kameez, Black Salwar, Black Coat, Black Shoe and White Socks

#### Ragging

Ragging in any form is strictly prohibited on and off the college campus. Any one indulging in ragging is liable to disciplinary action and to criminal prosecution under the relevant laws.

UGC Directives defining and prohibiting ragging are as follows:

#### 1. Definition of Ragging:

Any disorderly conduct whether by words spoken or written or by an act which has the effect of teasing, treating or handling any other student with rudeness, indulging hardship or psychological harm as to raise fear or apprehension thereof in a fresher or a junior student, or asking the students to do any act or perform something which such student will, in ordinary course, not do and which has the effect of causing or generating a sense of shame or embarrassment so as to adversely affect the physique or psyche of a fresher or a junior student. [Raghvan Committee Report, 2007, Para 3.19]

### 2. Prohibition of Ragging:

Ragging is strictly prohibited inside and outside the college.

#### 3. Penalty for Ragging:

Whoever directly or indirectly commits, participates in, abets or instigates ragging within or outside any educational institution shall be suspended, expelled or rusticated from the institution and shall also be liable to fine which may extent to Rs.10,000/-.The punishment may also include –

- i) Cancellation of admission,
- ii) Suspension from attending classes,
- iii) Withholding/withdrawing fellowship/scholarship and other financial benefits, withholding or cancelling the results. The decision to suspend or expel or other punishment shall be taken by the Head of the Institution.

#### 4. Undertaking:

As per the Hon'ble Supreme Court & UGC/MHRD, every student and the parent/guardian shall fill in an online Anti-Ragging Undertaking at <a href="https://www.amanmovement.org">www.amanmovement.org</a> (or) <a href="https://www.amtiragging.in">www.amtiragging.in</a> and they shall submit the hard copies to the Head of the Institution at the time of admission and for every semester till the course completion to the effect that she/he shall neither indulge himself/herself or instigate any other student in ragging or create nuisance to the academic atmosphere of the Institution.

Head of the Institution shall be responsible to take immediate action on receipt of the complaint/information about any instance of ragging and shall dispose of the complaint expeditiously, not exceeding two weeks. The inquiry may be conducted by the Head of the Institution himself or through his nominee or nominees. The Head of the Institution/Warden of the hostels should immediately lodge an FIR in respect of offences regarding which action may be taken under the Indian Penal Code. The aforesaid action would be in addition to and not in lieu of the disciplinary action which may be taken by the Institution.

#### **Sexual Harassment**

Sexual Harassment in any form is an offence hence punishable with criminal sanction with civil and criminal liability. With the enactment of the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013 Andaman Law College has constituted an Internal Complaints Committee. Anyone found guilty of sexual harassment of any girl will be immediately expelled from the college and the case will be handed over to police to be dealt as per the law.

#### Every student should be aware and abstain from the following -

- Ragging and eve-teasing. (Strictly prohibited, and attracts criminal and civil liability)
- Possession of any kind of weapon.
- Smoking, chewing pan, use of any type of tobacco products, and spitting
  in and around the college premises. Possession or use of intoxicating
  beverages or illicit drugs in the college campus.
- Leading, organizing, assisting or participating in any kind of unlawful activities that are detrimental to the academic ambience of the college.
- Use of mobile phones in any form in classrooms, seminar halls during sessions and also during examinations is strictly prohibited.
- Disrupting faculty members in discharging their duties.
- Defacing classrooms, electrical fixtures and college property.

On violation, the Principal has every authority to initiate action against the erring students.

#### Academic Calendar for the year 2025-26

Andaman Law College follows the academic calendar as prescribed by the Pondicherry University. The same will be notified to the students on its receipt from the university.


